The Parish Council is committed to its upkeep, but we need to clarify the ongoing ownership situation for insurance purposes.

## Parking Problems

The Council have been involved in trying to resolve several parking issues in the village. One has been impossible to improve on, and now there has been an accident, although thankfully, nobody was seriously injured. A hazard is caused mostly but not exclusively by two vehicles habitually parking on South Street or the pavement near the notice board. Vehicles parked in this location block the view of traffic coming from the Colchester direction, and this makes it very dangerous for pedestrians who have to cross the road as the footpath ends on that side of the road. This particularly affects schoolchildren, and some of them have contacted us about this. Having failed to improve the situation, the Council is now reluctantly considering applying for yellow lines to prevent the hazard. The installation of yellow lines will not be popular with everybody. We believe this limited use will not adversely affect the shop or public house, and the seriousness of the situation requires us to act.

## Speeding in the Village

Despite many people's perception to the contrary, there is not an "official" speeding problem in D'Arcy as determined by ECC Highways, who have carried out a number of surveys. We have, however, convinced the Local Highways Panel to extend the 30 mph limit in Tollesbury Road, which will hopefully give drivers longer to adjust their speed before entering the village. We are now thinking that there are some parts of the village where 30 mph is too fast for safety, so we are investigating having a 20 mph limit. Hopefully, there will be more news in the next edition of the Newsletter.


## Breaking News
