1. Welcome

The Chairman welcomed everyone to the Meeting.

2. Apologies for Absence

All Councillors were present.

3. Declarations of Interest

There were no declarations of interest disclosed.

4. District Councillors

Cllr Thompson - no new information to report.

5. Public Forum

The two residents reported that it had been brought to their attention that a parcel of land behind the old Doctors Surgery had been sold by Moat to the homeowner. It is understood that the land will be used for an additional garden area and the owner will also put in a driveway.

Cllr Thompson agreed to investigate further on behalf of the residents:

- 1) Can Moat sell the land? Has the land been sold?
- 2) Has the land been changed from amenity to garden?
- 3) Is planning permission required to erect a fence and install a driveway?

Was - liaise, as appropriate, with the Council's Data Protection Officer;

Changed to – liaise, as appropriate, with the Council's Data Protection Officer (if there is one);

Item 21 (a)

Was - The Council shall appoint a Data Protection Officer

Changed to - The Council may appoint a Data Protection Officer.

Item 18 (c)

Was – A public contract regulated by the Public Contracts Regulations 2015 with an estimated value in excess of £25,000 but less than the relevant thresholds in standing order 18(f) is subject to Regulations 109-114 of the Public Contracts Regulations 2015 which includes a requirement on the Council to advertise the contract opportunity on the Contract Finder website regardless of what other means it uses to advertise the opportunity.

Changed to - A public contract regulated by the Public Contracts Regulations 2015 with an estimated value in excess of £25,000 but less than the relevant thresholds in standing order 18(f) is subject to Regulations 109-114 of the Public Contracts Regulations 2015 which includes a requirement on the Council to advertise the contract opportunity on the Contract Finder website regardless of what other means it uses to advertise the opportunity unless it proposes to use an existing list of approved suppliers (framework agreement).

Resolved: to adopt the amended Standing Orders.



10.2 Financial Regulations

The following amendments were made to the Financial Regulations: **Item 11.1 (ii)**

Was – for specialist services such as are provided by solicitors, accountants, surveyors and planning consultants;

Changed to - for specialist services such as are provided by legal professionals acting in disputes;

Resolved: to adopt the Financial Regulations which had been brought in line with the Model Financial Regulations 2019.

10.3 General Data Protection Regulation (GDPR)

Resolved: to use the Maldon District Council Data Protection Officer, providing this service is still available, up to a maximum of £200 per annum. Unanimously agreed.

11. Tolleshunt D'Arcy Village Hall

Cllr Barwick reported the following:

- There is a slight delay on the Planning Application, there are some minor issues to resolve.
- The Committee has taken on the comments raised at a previous Parish Council Meeting and will more widely publish information on the funds that have been raised.
- So far £14,000 has been raised via funding and £14,000 via community funding. Once £50,000 has been raised, a fundraising thermometer will be put up in the Village Hall.
- Monthly Community fundraising events have been arranged.
- A funding application will be submitted to the National Lottery in March.
 Further funding applications will be submitted once planning permission has been granted.

12. Annual Parish Meeting

Resolved: subject to availability of the Village Hall, to hold the Annual Parish Meeting on Friday 27th March 2020. Unanimously agreed.

13. Tommy Silhouette

Resolved: to display the Tommy Silhouette in November/December.

14. Maldon District Council – Amended Affordable Housing and Viability SPD Notification from Maldon District Council that the Amended Affordable Housing and Viability SPD was adopted on 19th December 2019 was received and noted.

15. Consultation

15.1 Recreational disturbance Avoidance and Mitigation Strategy

The Essex County Council Recreational disturbance Avoidance and Mitigation Strategy (RAMS) Supplementary Planning Document (SPD) Consultation was received and noted.

There were no comments from the Parish Council.

17. Representative Reports

17.1 Burial Ground

17.1.1 Update from Clirs Brown, Henderson and Scott

The Clerk reported that a resident had expressed concern that during heavy rainfall, the water was running on her husband grave.

Action: Cllrs Brown and Scott to investigate further.

The Chairman reported that an application had been received for a memorial in the Burial Ground which was very different from the existing memorials.

Action: Cllrs Brown, Henderson and Scott and the Parish Clerk to meet with the applicant to discuss further.

Action: Burial Ground Representatives to carry out a review of the Rules and Regulations for the Burial Ground.

17.2 Recreation Ground

17.2.1 Update from Clirs Brown, Dorman and Munson

17.2.2 Monthly Play Equipment Inspection Report

The Chairman had not carried out the inspection but would ensure an inspection was carried out before the next meeting.

17.3.1 Update from Cllr Henderson

Cllr Scott advised that he had reported the street nameplate for South Street which had been tied to a tree to Essex County Council. As the nameplate was still in place, they would not proceed any further at this stage.

Action: Clerk to write to the resident who took out the name plate when removing a tree and request that they reinstall in.

Cllr Scott advised that meeting that had been scheduled was cancelled as the additional reports from Essex County Council had not been received. The meeting will be rescheduled.
