# Grant Awarding Policy V1.0

### 1. Introduction

- a) Tolleshunt D'Arcy Parish Council will consider applications for grants from voluntary groups or charitable organisations.
- b) To qualify for an award the applicant must be able to demonstrate that any funding from the Parish Council will benefit the Parish, or residents of the Parish.
- c) Grant applications will be dealt with by the full Council.
- d) In determining the validity of an application, the Council will refer to the following guidelines:

### 2. Applications will be considered for the following purposes:

- a) For the purpose of purchasing equipment either in part or in full.
- b) For the funding of transport that will enable group members to partake in a group trip or outing regardless of their incomes.
- c) For training activities, or to purchase the expertise of an outside trainer/ instructor/ facilitator.
- d) For activities that raise the profile of the area.
- e) For running costs of a viable group that is experiencing a period of hardship.
- f) For hosting special events or celebrations.
- g) For the provision of recreational facilities.

### 3. Conditions:

- a) Grants will not be awarded to individuals.
- b) Additional applications within a 12 month period will not normally be considered.
- c) The award must be used for the purpose for which the application was made.
- d) Any awarded grant underspends shall be returned to Tolleshunt D'Arcy Parish Council.
- e) All awards must be properly accounted for and invoices/receipts should be sent to Tolleshunt Darcy Parish Council to demonstrate expenditure of the funding on the specific project to which it was awarded. If the Parish Council is not satisfied with the arrangements, they reserve the right to request a refund of monies awarded.
- f) Donations to Registered Charities in response to a general fundraising appeal may be considered if there is a benefit to residents of the Parish.
- g) If any other funding becomes available for your project that negates the need for our grant, Tolleshunt Darcy Parish Council should be informed immediately
- h) The policy may be amended at any time by Council following a motion having been published on the agenda beforehand being carried.
- i) On completion of a project a letter of thanks should be sent to the Council and if possible, an acknowledgement of the Parish Council's contribution should be made.
- j) A report should be sent to Tolleshunt Darcy Parish Council within 6 months of the grant being awarded updating on the progress of the project.

### 4. Eligibility:

- a) Any Charity, Voluntary Group or Community Organisation operating within the parish.
- b) Agencies that operate within the Parish and are of benefit to the local community, with the following provisos:
  - The Parish Council will not fund activities that it considers to be the responsibility of a Statutory Authority.
  - Applications from schools for an activity that takes place within the school day will not be considered.
  - The Parish Council will not fund activities outside its powers and functions.

### **5.Submission of Application:**

- a) Applications must be submitted by 1st September for consideration in the following year's budget.
- b) The application form must be completed in block capitals in black ink.
- c) The applicant should retain a copy of the form.

## 6. Publicity:

a) The support of Tolleshunt Darcy Parish Council must be acknowledged in all publicity materials.
